Theme: Defendant is a victim of abuse/neglect/trauma/institutionalization

- Child Abuse/Maltreatment
 - Physical abuse
 - Sexual abuse
 - Emotional abuse
 - Witness to violence in the home, drug use, sex work in the home
- Neglect
 - Childhood hunger/malnutrition
 - Poor hygiene/no running water or electricity in the home
 - No child caretaker for long periods
 - Chronic truancy permitted
 - Failure to enroll in school
 - Out-of-home placements
 - Multiple residences with non-familial members
 - Abandonment
 - Allowed to use alcohol or drugs
 - Accidents in the home (with or without medical intervention)
- Trauma
 - Witness to abuse/violence in the home
 - Natural disaster (fire, flood, etc.)
 - Parent or sibling death
 - Victim of sexual or physical abuse
 - Victim of serious injury, threatened death (or observed this in others)
- Institutionalization
 - Foster care/emergency shelter placement
 - Juvenile justice facility
 - Hospital (medical or mental health)
 - Substance use treatment

Theme: Defendant is loved

- Client has active support from family/long term friends/mentors
- Client is a positive influence on:
 - Own children
 - Children in extended family
 - Children in the community
- Client has many visitors, money on books, connected relationships
- Client has a place to stay, job in the community, post-release supports and mentors

<p>Theme: Defendant has substance use disorder but wants treatment</p> <ul style="list-style-type: none"> ● Current/History of substance use disorder <ul style="list-style-type: none"> ○ Age of first use (for each substance) ○ Most recent use (for each substance) ○ Average day's use (kind of substance(s) used, amount, route of administration, duration of use, total amount used in a day) ● Prior efforts to stop use and result(s) ● Prior treatment episodes (including detox and civil commitment) ● Medical consequences of use (cirrhosis, cellulitis, hepatitis, endocarditis, etc.) 	<p>Theme: Defendant is religious/Is involved in community groups</p> <ul style="list-style-type: none"> ● Childhood religious involvement ● Religious family ● Traditions/tenets (beliefs) of family, client ● Pre-offense religious involvement (in adulthood preceding offense) ● Participation level ● Frequency ● Activities with religious group ● Current supports from religious group ● Post-offense religious involvement (during incarceration) ● Visit from Chaplain ● Church/chapel attendance ● In-pod religious study individual, group

<p>Theme: Defendant is the product of his/her family (biological factors)</p> <ul style="list-style-type: none">● Family History of Illness – List for each family member<ul style="list-style-type: none">○ Alcoholism○ Drug use○ Medical problems – chronic○ Medical problems – terminal○ Mental illness○ Suicide○ Interpersonal violence○ Criminal behavior	<p>Theme: Defendant is remorseful</p> <ul style="list-style-type: none">● Evidence of remorse in words, actions● Expressed remorse, concern during confession, to police● Statements made to defense team about remorse● Written/prepared statements of remorse● Willingness to make overtures to victim(s) family● Mental health evidence of guilt (PTSD, sleeplessness, suicide attempts, behavior changes)
<p>Theme: Defendant has medical conditions (costly to incarcerate)</p> <ul style="list-style-type: none">● Diabetes● Asthma or COPD● Heart problems● Need for surgery● Cirrhosis● Hepatitis● Mobility problems● Neurocognitive disorder	<p>Theme: Defendant is less culpable than others</p> <ul style="list-style-type: none">● Duress/compulsion by co-defendant(s)● Co-defendant is influential because of:<ul style="list-style-type: none">○ Size○ Strength○ Experience/life history spent together○ Threats of violence/actual incidences of violence in front of client○ Past criminal history○ Co-defendant was armed/weaponry/use of force○ Co-defendant was lover/relationship partner○ Co-defendant was parent○ Client has a dependent personality○ Client is intellectually disabled, easily coerced (a follower)○ Client lack of criminal motivation○ Did not bring a weapon to the crime○ Did not flee the scene○ Did not threaten, endanger others○ Possible accident or

<p>Theme: Defendant was not himself/herself at the time of the crime</p> <ul style="list-style-type: none"> ● Severe substance use disorder ● Recent trauma ● Heat of passion ● Extreme emotional state leading up to/at time of the crime ● Recent change in medications ● Recent life stressors ● Severe grief/loss ● Altered state of consciousness (from what?) ● Recent medical diagnosis ● Recently uncovered past secret 	<p>Theme: No criminal history/aberration</p> <ul style="list-style-type: none"> ● First time offender ● No prior violent offenses ● Only prior low level offenses ● Only prior property crimes ● All crimes substance use induced Traumatic or significant life event(s) before incident ● Client was typical before and has returned to typical behavior after crime ● Client can reflect on an out-of-body experience during crime ● Memory problems at time of and after crime ● Extreme emotional state leading up to/at time of the crime

<p>Theme: Defendant never had an opportunity to succeed</p> <ul style="list-style-type: none"> ● Poverty ● No electricity ● No running water ● Environmental factors growing up ● Ruralness (no contact with outside world) ● Other factors of rural growing up ● Hardship of childhood ● Bullied as a child ● Education cut short ● Failure to thrive ● Responsibilities as a child not age 	<p>Theme: Defendant has family stability/community support</p> <ul style="list-style-type: none"> ● Phone calls, letters from family and/or community members ● Outreach to defense team by family, community members ● Willingness to house, employ, financially support client ● Willingness to be present at trial/plea ● Willingness to provide testimony, letters of

<p>appropriate</p> <ul style="list-style-type: none">● Early (young) employment● Sacrifices in childhood● Lack of parenting● Lack of stability, security in childhood● Message client was raised with● Survival skills honed early● Never taught how to conduct self as an adult● Limitations of 'the system'● Foster care system did not take care of the client● Therapy/treatment was inadequate to take care of the client● Missed opportunities in educational setting● Missed opportunities in medical setting● Missed interventions by family/extended family	<p>support</p> <ul style="list-style-type: none">● Willingness to provide clothing for client for court● Willingness to meet with defense team● Willingness to write letter of support on behalf of client

<p>Theme: Lingering doubt</p> <ul style="list-style-type: none">● Innocence● Case based on shaky circumstantial evidence● Viable alibi witnesses● Long jury deliberation● Rallied community support	<p>Theme: Impropriety by the state in investigating the case</p> <ul style="list-style-type: none">● False statements● Brady issues● Issues with the science● Issues with the State's experts● Community bias/sensitive issues of attention● Inappropriate conduct (prosecutor, police)
